The research question...

"How might collaboration/partnerships help solve the key issues around housing availability/affordability?"

To provide some agreed definitions:

- Collaboration a group effort to achieve an agreed goal
- Partnership sharing of risk and opportunity



The issues...

1. CONSCRUCTION COST 2 HOUSING, AS AN ASSET

Acknowledging the wisdom of the crowd, we asked: "What are the key issues to address?"



The voting...



to establish the "top three":

Seventeen issues were collected and democratically voted

- 1. Housing as an Asset 2. Community Attitudes 3. Planning Timeframes
- In retrospect, these map quite neatly into three themes...





The first key issue:

"Australia's fiscal, monetary and taxation settings make housing an investment option, rather than a basic human

What can we do about it:

Lead the discussion on other options...

Short term goals

1. Reciprocity – Win / Win.

2. Advocate for bi-partisan political will on policy

changes (e.g. negative gearing, capital gains tax).

Long term ambitions

- 3. Government investment substantially in public housing.
 - Incentivising Institutions (Super Funds).
 - Education on housing as a human right, benefits of density done well.
- 6. Providing greater housing diversity multigenerational / demographic.
 - Reduce the cost of housing to increase supply.





The second key issue:

Community housing used to be viewed as a pathway to home ownership. Now it has developed a stigma, becoming seen as a welfare issue.

What can we do about it?

Be part of a culture shift towards "helpful housing" and ensure good design drives these projects.

1. Developers (let's call them investors!) connecting with -

Community Housing Providers.

Union/employer partnerships.

Working with government – to mix social and private housing.

Partnerships with media.

Show community they get something in return.

Match making apps for housing for people in need.



The second key issue (continued)...

- Long-term Ambitions
- 3. Diversity in tenure, co-operative housing models.
- 4. Social support system improvement in incentives.
- 5. Integrated communities
 - Mixing up demographics.
 - Permanent quotas for social housing in all developments.





The third key issue:

"Building houses takes too long and is tied up in red tape."

What can we do about it:

Advocate for faster Approval timeframes...

Short-term Goals

1. Use AI to triage Development Applications and Construction Certificates.

2. Community engagement – explore different, faster models.

3. Reworking the planning system

• Outcomes defined to focus the applicant and Council.

Long-term Ambitions

4. Normalise industrialised construction such as Pre-fab and Modern Methods of Construction.

5. Celebrate and emulate examples of Best Practice.

6. PCA role expanding into Development Assessment, expand Complying Development.
